# **Frequently Asked Questions**

#### I am an existing patient and have already been receiving How will I know when I need to re-enroll? some of these benefits. Why should I enroll?

#### Will this change or affect my insurance?

### Do I need to pay for membership if I am a Cash Patient?

Cash patients pay fair prices for each patient visit and have the option to enroll in the boutique plan for a payment of \$250 or \$500 for gynecology and pregnancy services, respectively.

## What if I am enrolled under the Gynecology boutique plan and become pregnant?

If you become pregnant, you will be required to pay \$750 for the obstetric membership and the time remaining on your membership will be extended by 12 months.

In the unfortunate event of a 1st trimester pregnancy loss, \$250 will be credited back to you and you will have the gynecology level benefits for the remainder of the 12 month term.

#### What is the enrollment period?

Your membership fee allows for 12 consecutive months of membership from the date of purchase.

#### Can family members use my membership without enrolling?

No, your plan is for you alone. Your membership discounts can be used to purchase services for your minor dependents,

#### Can I make installment payments for the plan I choose? No, all payments must be made in full at time of enrollment.

#### Is the fee tax-deductible? May I use my Health Savings Account (HSA) for the fees?
